

CARBOHYDRATE/CADROIT CONTACT REPORT

29 April 55

Date, Time, and Place of Meeting: 25 April 55, 1900-21145, CARBO's Ap.

Present: a. CARBOHYDRATE b. []

1. After a few amenities, CARBOHYDRATE delivered the following written material:

- a. Completed Fragebogen for: K. Thärmer, Edith Schroedter, Wolfgang Schroedter, Ernst Berends, Edwin Bothor, Lotte Matthes, Wilhelm Schubert.
- b. One written refusal by Maria Frits saying she would not fill out another Fragebogen since she already has filled out one (the incomplete form designed earlier ~~by~~ during the CADROIT investigation) which CADROIT has, and since whom she is employed only as part time help. For further scrutiny.
- c. Further report concerning SFS efforts to recruit Blum of the staff through his E st Berlin brother, B. Schwabe. The SFS is trying to get Schwabe to learn Blum's W. Berlin address, which he claims he cannot learn. Report attached. Previous events in this case already reported.
- d. Address change of staffer. Herla Heribeck now lives at ~~Rin-Bankstrasse~~ Lanckwitz, Thaliaweg 13, No phone.
- e. Copy of letter from Simoni to CARCARANA through the warden, asking whether latter objects to his 4 yr. old son's leaving the country with CARCARANA 2, and noting that Simoni has been informed that she intends to leave in July, whether or not she then has a divorce.
- f. Copy of letter to Simoni from CARCARANA admitting that he had an affair with a W. Berlin woman early in 1953, and saying that his mother has further details.
- g. CARBOHYDRATE's SFS files for the last two years, as previously requested by [] This is stated to be all that CARBOHYDRATE or CADROIT have in the way of info re the SFS for the last two years. NOTE: This info has been passed piecemeal to the C/O in touch with CARBO as it was received by CADROIT, and thence to GART (and thence, [] understands, to F. MEUFRT) CARBO told [] earlier that [] had earlier gotten all of CARBO's SFS files and reproduced them, so the current material will probably be all that is of interest. FURTHER NOTE: This material has been in the meantime passed to [] for scrutiny and disposition. It has been returned to [] with the info that GART had most, but not all of the info contained. The new info had been copied. The file will be returned to CARBOHYDRATE.

2. CARBO reported orally:

a. CARGARANA 2 had written her mother in law stating the former will leave Germany for Amerika in July, w. or w/o divorce. The mother in law saw Simoni, stated that perhaps the son, Wolfgang, should not go. (This is the reason for Simoni's letter. After all, he is supposed to be representing CARGARANA's interests.)

b. ~~How~~ KAISER's debts total DM 1,768.25 now. He gets 318/mo. salary (through June 30). Two children. He has worked in the past for DTLINEN, LOCASSOCK, ~~and~~ VPO. Courier work. With CADROIT since 1951. CARBO noted possibility he might have been interviewed by [] during investigation of CADROIT, possibly LOFLUTTERED. He will return to CADROIT on Fri. 29 April. Renard does not want to deal with him (quite properly). CARBO and Ristel will meet him. It is not known just what KAISER wants specifically. It should be noted that he gets unemployment payments after June, so will not be absolutely destitute unless his creditors ~~are~~ are successful in taking everything he has. CARBO obviously looked to [] for an answer to the problem. Various solutions were discussed and rejected (having CADROIT pay of debts again, having ~~some~~ debts paid of w/o identifying source of funds, etc.) The immediate problem is the pressure of the debts which might conceivably drive Kaiser off of his balance. The question is how to get the debts paid w/o starting Kaiser on the road to blackmail or something similar. Meeting arranged for 28 April to discuss problem further.

c. Re [] earlier request for the Lieberman file and personalia, Dr. Wolf almost always has the file; it is hard to get without arousing suspicion. The case has been turned over to the LfV by Ladell. When? not long after []'s earlier query re the case. The crypt for the case with the LfV is "Zeppelin". All info went to LfV. Whom did Ladell deal with in the LfV (Brun no longer being there)? CARBO did not know. [] instructed to bring name and file at next meeting. Name in any case, and file when opportunity presented itself--hopefully by next meeting.

d. Pursuant to earlier instructions, staffers have been queried and their names (with 11 exceptions) have been placed upon the police endangered list. There are two types of lists--"O" (More restricted--police patrols are changed to insure very frequent check of residence) ~~and~~ "P" (more common--persons must telephone police himself, then will get quick action). Wierichs of Sbt. V asked CARBO to keep as many of the "O" list as possible, due to difficulties such arrangements cause the police. ~~Following are the "O's";~~ Following are the "O's"; ~~all others are "P's".~~ all others are "P's".

- Westphal (nervous--possible SFS kidnapping attempt years ago)
- Frau von Ro.
- Beelits (blind)
- Ohlson
- CARBO
- Dr. Wolf (knew Stein wall; also the Diller affair)
- LADSELL (already on "O" list, but will be confirmed)

e. Per previous instruction, CARBO had checked the status of the arrangement whereby 7-9 policemen ~~are~~ are always available in a room in the CA ROIT chief bldg. taking their off duty spell. There has been no change in this arrangement--it continues as before.
