

CARBOHYDRATE/CADROIT Contact Report

27 October 1955

Date, Time, and Place of Meeting: 26 October 1955, 1930-2200, CARBOHYDRATE's Apt.

Present: a. CARBOHYDRATE b. []

1. After the usual amenities, the following points pertinent to CADROIT's work were discussed:

a. CARBOHYDRATE delivered personality information concerning the two cleaning women who had worked in CADROIT during Jan 1955 and taken ~~them~~ the waste paper to the cellar to be burned. They are: Frau Lieselotte NAGEL geb. KUEHN, Schlachtensee, ~~Blind~~ Bital Frits Str. 7, and Frl. Ella Drees, geb. 3/6/1899, Schlachtensee, Lagardestr 20. ^{earlier}

b. CARBO also gave the following info stemming from/queries by [] on the many in which the SFS could have gotten the list of 73 visitors:

(1) Karl SCHULZ burned the wastepaper when Schadow was ill, as well as Dreesen also for part of that time. Schadow was ill during the following precise periods: 10/7-11/8/54, 11/12/54-7/2/55, 11/3/-11/3/55, 26/3/-30/4/55, Schadow took Schmidt's place during the period 9/5-11/6/55, while Heynens was on leave, and was replaced by Schmidt.

(2) Gebel, the now deceased Pfoertner in Linden., had been SCHULZ' predecessor as supplier of stamps and had gotten them from the same ~~Stammbuch~~ East Berlin office, W 9, according to information which CADROIT received at the time.

(3) Emma Boese, SCHULZ' common law wife, was visited approx. two weeks before his flight to West Berlin in her apartment by uniformed VOPG who questioned her concerning SCHULZ' whereabouts. Approx. two months after SCHULZ' flight she was visited by a man dressed in civilian clothes who asked her to accompany him. She refused on grounds that she could not leave her sick child. The civilian left after remarking that an appointment would be made for her later

which she would keep. When Froelich later asked SCHULZ re any new developments, SCHULZ stated there had been no more visits or other developments. BOESE gave the same answer when she was later questioned herself by FROELICH. This info came from Froelich, whom CARBO had queried since our last meeting.

(h) Night watchmen during the period concerned were:

Bernhard LUEDTKE until 4/1/55, who then succeeded by the current Otto Geller, father of a Referent, and

Friedrich SCHILTZKE, until 31/10/54, who then replaced by the current Wilhelm SCHUBERT.

(This info confirms the personnel list already in our possession, and adds precise dates)

c. CARBO delivered as earlier requested a list of present staffers who were formerly DDR MA. Twenty names are included on the list, which was made up by LADELL. Includes some of the most important staffers, as could be expected. Includes one former CADRON MA (Denninghoff).

d. CARBO delivered a three page report concerning discussions with fms Bernhardt of NTS concerning relations between that organization and Karl SCHULZ. The report generally tends to confirm the impression that all was not in order with SCHULZ. He had been put in touch with NTS by Kaiser and had thereafter procured stamps for the organization, giving Jungmann as the name of the source within the East Berlin branch postoffice. He offered to see that Jungmann was furnished with NTS propaganda letters which the latter would distribute into mail sacks (a very involved and dangerous method, as opposed to the normal insertion in mailboxes--this is not believable). He was given letters containing control letters, which were not returned. When informed of the latter failure, his control letters thereafter were returned through the mail, but only the West Berlin control letters, not the East Berlin letters. There were indications that he had passed

on to some one else certain low-security telephone numbers which NTS had furnished him (see report for details). SCHULZ later offered to ~~arrange~~ give Bernhardt rides in his newly purchased car (preparation for a quick trip to the East?). Bernhardt suggested informing Abt. ~~EE~~ I, which CADROIT has done.

c. CARBO delivered a list of ~~xxxxxx~~ 73 names which had come into Sfs possession, giving both true name and the name carried by the Sfs in those cases where the Sfs list had been in error. Attached, with notations indicating the status of the warning action (which have been warned, have fled, have not yet visited CADROIT, etc.)

d. CARBO delivered a Fragebogen on Frits ~~EDHEM~~ RODIG, the former CADROWer who has ~~apparently~~ been tentatively earmarked for the security watch job. CARBO noted he knew Frau von Ro. and LADELL, had carried out some surveillance jobs for Froelich.

e. CARBO delivered a report re a visitor who, upon visiting CADROIT for the first time, had inquired of a young man (29-30) raking leaves near the building where he could find the office. The young man had ~~replied~~ replied that the visitor "certainly did not intend to visit that laughable club-the whole DDR would know of it within a day." The young man appeared to be a Heizer in a house ~~xxxxxx~~ across the street from Linenstr. 29 "where two green American automobiles often park". CARBO noted that remarks like that in question did not really help, and hinted that it would be appreciated if some way could be found to say the right word to the American employed Heizer. (Check showed we have no safehouse in the vicinity).

f. CARBO delivered a report re a visit by a refugee who had been a member of a Schwerin group charged with gathering military information. Attached report gives the names of the group members. He had been briefed by the "Sammelpunkt" for the information gathered by the group, who had changed his former covername of Norbert to the current Thomas, that if

if the group ever had any trouble he should get in contact with CADROIT, where he should ask for LADELL or "Rosenberg". The visitor was warned in time to flee, now wanted to warn the other members of the group, and in particular another member named Stiegler through a cover address Gustav Herrmann, Schwering, Puschkinstr. 30. CADROIT denied any interest or connection. [] noted the possibility of provocation, but did not discuss with CARBO the possibility that this was ODOPAL or MID using the name of CADROIT for good faith purposes, etc.

g. CARBO delivered written report giving additional info on the previously reported arrest of MA "Rieger" showing he had been arrested and convicted not for CADROIT connections but for work with a Western IS.

2. ^{NA} CARBO reported that former Mitarbeiter "100", true name Willy MENSKY, who had earlier been CADROIT'S source of the VOPO Fahndungsbuch, and who had later been turned over to the West Berlin police, had fled to West Berlin. He had visited CADROIT to complain bitterly that he had been interrogated by an American Dienststelle right off of Clayallee (precise address not given) to which he had been sent by the BNAV. The young American who had spoken with him had shown that he had been fully informed of Minsky's connections with CADROIT and Abt. V, which CARBO had often reassured him would be told to no one, etc. CARBO requested that incidents such as this be controlled in the future, if possible, since it gave CADROIT a bad name and prevented it from getting new MENSKY'S in the future.

3. CARBO delivered a report stating a visitor who had been released from the Rummelsburg prison in the DDR had been requested by a fellow prisoner named Heinz LUEDIGKE to carry a message to CARBOHYDRATE that the leaders of the SIS interrogation center at Prenslauer Allee are Hans Frock and Hans Wolff. Luedicke stated that he had worked together with CARBOHYDRATE under the covername,

"Fleming". According to Luedicke, he had been sentenced on 20 May 1954 to four and one-half years for ODOFAL work. CADROIT traces revealed no mention of a Luedicke. CARBO stated he did not remember a LUEDICKE, but due to the passage of time could not be sure that LUEDICKE was not one of those visitors to CADROIT whom he had turned over to [] without HENARD's or [] knowledge in the months following upon his insertion in CADROIT. CARBOHYDRATE^{requested} a check to determine whether LUEDICKE was someone he had turned over in this manner or not.

4. CARBOHYDRATE also delivered three reports re SFS ~~approaches~~ approaches or actions, as follows:

a. Dr. Michel, who has an office outside of CADROIT and handles a number of straight legal problems involving MA, was informed by Abt. I that a Horst Wiedemann from Dresden had been released from SFS prison with the EKI of luring Michel into the Eastern sector. There have also been other indications in the past that the SFS has interested itself in Michel. On 19 Oct his secretary (the wife of the former head of the Berlin LFV, Brunn, incidentally) saw a man who took three photographs of Michel's office. He got into a car immediately thereafter and drove off. On the same day a man questioned his neighbors re his habits, etc (as previously reported). Michel has given all of this info to the police. This could very well be preparation for a break into the office, which the SFS might very well see as another CADROIT office. A number of visitors go from CADROIT to Michel's office. He should have no true name of MA in his office, but there are many names of visitors there. Michel has requested increased coverage by the police. [] suggested to CARBO that a good burglar alarm system might well be immediately installed (cost estimate: DM 300). This might also bear more scrutiny from the standpoint of what names are kept in the office, and how they might be protected or removed. Attached report (in the form of a letter to HEN.) to be

returned to CARBO later.

b. Report by Rank/Reuter concerning an approach to him by a former friend and Erfurt lawyer who visited him in West Berlin with the SFS EEI to induce him to return to the DDR. Although this lengthy report contains the names of many Erfurt lawyers and other detail, it appears to fall into the normal pattern wherein the SFS approaches a friend of a CADROIT staffer who is still in the DDR and gives the EEI of visiting the staffer and inducing him to return to the Zone. Attached.

c. Report on most recent visit to staffer Bluhm by his East Berlin residing cousin, who comes at SFS behest. This action has been under way for some time. The SFS has now instructed the cousin to offer Bluhm a chance to either: 1/ return to the DDR (a la Wagner, presumably) or carry out espionage in his present position. The latter is noteworthy since the SFS does not usually put this into words, but talks mainly, in the ordinary case, of returning to the DDR. Report attached.

5. With the completion of the above business, [] noted that he had to say farewell, since he was leaving for a period of approx. 29 three months for a long delayed vacation, after which he might receive a different assignment and not return. He hoped to return, of course, etc. While [] was away, [] would take over [] functions. Unfortunately, []'s other commitments prevented his ~~attendance~~ attending the present meeting, but he could always be reached in the usual manner. [] had discussed ~~the turn-over~~ the turn-over with [] and who currently has much to do as a result of the arrest of LADELL, etc., and may not be able to see CARBO for ~~two or three weeks~~ two or three weeks, or so. During this period, therefore, CARBO should forward all material through LADELL. For unusual matters, of course, [] can be reached, etc. CARBOHYDRATE took this well and the rest of the evening was spent in general discussion of photography, etc.
