1. Since CAPERCH-11's release from prison on 8 December 1966, we have completed her debriefing (References) and have spent the remainder of time settling a number of problems preparatory to terminating the agent. One of the first problems to arise concerned reimbursement of the agent for her term in jail. As we announced in Reference A we would do, we paid CAPERCH-11 6,000 DMW (US \$1,500.) according to the CAVERVE formula, 3,000 DMW (US \$750.) termination bonus, and all of her back salary which had accumulated while the agent was in prison. All three items together amount to a total of DMW 12,300 (US \$3,075.). When we offered this amount to CAPERCH-11 on 7 April 1967, she expressed disappointment and maintained that this amount was insufficient compensation for what she had gone through on our behalf. She had several arguments why she thought she deserved more. She reminded us that a mistake in our document caused the arrest, not any mistake on her part. Then following the arrest she was successful in concealing her past agent activity from the MFS. A final argument she brought

forth was that while in one of the East German prisons she had been placed in a cell with a woman suffering from TB. As a consequence she contracted the disease too.

2. In discussing these arguments with CAPRECH-11, we admitted that she deserved special consideration but added that the sum we offered was more than we generally give and was the maximum we could pay. This, however, did not satisfy her and although she took the amount offered and signed a receipt for it, she refused to sign the quit claim. Later we returned with an additional 2,000 DEM (US \$500.) and said that there was absolutely no possibility of getting any more. Subject, while not particularly happy at this result, nevertheless then agreed to sign the quit claim (using her alias "Stark"). In addition to giving Subject money, we also sent an application on her behalf to the West Berlin authorities which would give her recognition as having been a political prisoner, making her thus eligible for various benefits under German law.

3. Finally, we also had to indemnify two of the individuals whose names CAPRECH-11 had given to the KGB as part of her cover story. CAPRECH-11 had actually named three individuals, but Identity-1 and Identity-3 are the only ones still located in Berlin. In Identity-1's case we awarded her 1,500 DEM (US \$375.) which is supposed to cover all future air travel to and from Berlin. Besides getting Identity-1 to sign a receipt for this amount, we also had her sign a statement agreeing to withdraw a complaint she had made to the West Berlin police about CAPRECH-11's mention of her name to the KGB. Identity-1 did indeed carry out this agreement as we later ascertained. In Identity-3's case we gave him 500 DEM (US \$125.) only for air travel costs over the next three years, the extent of time he expects to remain in Berlin before moving elsewhere.

4. At the time that we paid CAPRECH-11 compensation for her arrest, we also told her that after all problems connected with her resettlement were solved, we would have to terminate our relationship. The explanation we gave for the termination was that because of her arrest we could not risk using her again as a courier. CAPRECH-11 readily accepted this explanation and added that she had expected the termination. Following our last meeting with CAPRECH-11 which cleared up the final problem, we do not intend any further contact with her.
