



Congo: [Tshombé is making it increasingly clear that he intends to delay on steps to integrate Katanga with the Congo until an acceptable constitution has been formulated.]

[On 18 September, he charged formally that serious discrepancies existed between the UN integration plan he accepted on 3 September and the implementation schedule presented a week later. He objected to the schedule's provisions for delivery of Katangan foreign exchange to the central government and to the steps outlined for military integration, as well as to the projected closure of Katanga's Foreign Ministry and overseas offices.]

[Meanwhile Adoula and Tshombé disagree on the procedure for drafting the constitution. Adoula has rejected Tshombé's request to name an expert to meet with the UN specialists now working on the document in Leopoldville and has expressed fears that Tshombé wants an extended article-by-article discussion of the 220-article draft constitution.]

***Argentina:** (Information as of 0445 EDT) The three-day-old power struggle between factions of the Argentine army ended in victory for the rebel forces, according to an early morning press report. President Guido announced the resignation of his entire cabinet and the resignation and retirement of the military high command which had been opposed by the Campo de Mayo rebels, thus eliminating the chief cause of the struggle.

An early morning cabinet meeting today reached a decision to stop the struggle. The President's communiqué ordered the troops back to their barracks and announced that "the military situation is normal."
