Egypt-USSR: [redacted] have reported that they observed Soviet tactical missiles in Egypt.

Their report is unconfirmed and not clear in its details, but [redacted] believe that what they saw were two Scud surface-to-surface missiles being transported toward Ismailia near the Suez Canal.

[redacted] the FROG tactical rocket, one version of which is markedly similar in appearance to the Scud A, has been delivered to Egypt. Egypt reportedly placed an order for FROGs two years ago and was scheduled to receive some in the fall of 1967.

[redacted] while the Scud is a single-stage weapon with a range of 160 nautical miles. The FROG-1, the version which bears the most resemblance to the Scud A, is capable of carrying a 1,000 pound warhead about 18 nautical miles.

Both the Scud and FROG can carry chemical or nuclear warheads, but it is highly unlikely that the Soviets would provide anything but conventional high-explosive warheads to Egypt. [redacted]





Peru: President Velasco has told [redacted] [redacted] he will expel all Americans from Peru if US aid and Peru's sugar quota are suspended because of the expropriation of International Petroleum Company holdings. [redacted] explained that this matter is governed by US aid legislation and recommended that Velasco concentrate instead on reaching a settlement with the company. The President's threats were apparently intended as a message for the US ambassador, who comments that the Peruvian Government now at least understands the possible serious consequences of its nationalistic actions.
