My dear Mr. President:

In reading Max Freedman's column in the Los Angeles Times today, I could believe that much bickering and conflict existed between the State Department, Defense Department and the CIA concerning South Viet-Nam and other countries.

Later today I heard radio commentator William Winter, who openly accuses the CIA of setting policy and initiating practices which violate human dignity and defeat State Department political strategy. Further, Mr. Winter states the CIA actively engages in bringing about the downfall of heads of foreign governments who openly endeavor to break feudalistic powers through land reform, social movement, or even neutrality and compromise. The countries and geographical areas he named included among others, Iran, South Viet-Nam, Laos, the Caribbean, and Central America.

It seems incredulous to me that a department (CIA) of this government can create policy and initiate action which violates U. S. policy without covert approval of higher authority. It seems incredulous too, that the CIA should be completely autonomous to the extent that it need not coordinate its actions with other departments. Yet these are the accusations being made.

Is then the CIA a victim of repertorial sensationalism? Or could it be the scapegoat of the nation's mistakes, i.e., the Bay of Pigs? Or is it true that it acts autonomously, and within itself acts as a department of state and defense with the power and authority to make limited war, to compromise, and to decide who is the proper person to be the head of government of a foreign state, and what should be that nation's political, social and economic policies? I do not know, but it seems to me the citizens of this nation will want an answer to these questions.
