**NSC SPECIAL COMMITTEE ON TECHNICAL SURVEILLANCE COUNTER-
MEASURES**

POLICY STATEMENT

June 13, 1962

At the eighty-sixth meeting of the NSC Special Committee a proposed policy statement concerning guidance on the release of information about technical surveillance counter measures was unanimously approved by the Committee members. The adopted policy is stated below.

"In order to afford better protection to the interests of the United States in the field of technical surveillance countermeasures and to prevent possible unintentional disclosure of information which might be detrimental to the procedures, operations or interests of the member agencies or departments of this Special Committee, it is recommended

That whenever an agency or department having representation on this Committee contemplates public disclosure of information relating to countermeasure activities or equipment or contemplates public disclosure of information on positive devices or techniques which might impinge on the countermeasure efforts and responsibilities of the United States intelligence community, such agency or department should coordinate such disclosure or release of information with the National Security Council Special Committee on Technical Surveillance Countermeasures."
