SUBJECT : Review of Agency Air Proprietary Projects

1. The Comptroller's recommendation that the survey of CIA Air Activities be referred to the Executive Committee for Air Proprietaries for consideration prior to review by the Financial Policy and Budget Committee is approved. Although the study contains the basic information requested by the Comptroller in July 1962 (reference B), this report is only the first step in a comprehensive review of the Agency air proprietary projects which the ExComAir will undertake.

2. It is therefore requested that the ExComAir use the information contained in referenced survey as background material for the preparation of a detailed analysis of current Agency air proprietary projects to determine if these projects have provided sufficient operational support to the operating components to justify the time and money we are presently spending. I think it is pertinent to note that the IG survey of air activities, dated February 1962, seriously questioned the operational value of nearly all of our air proprietaries. What I am interested in is a hard look and a realistic evaluation of the air proprietaries' contribution in support of Clandestine Services.
