[] On 18 August, Souvanna
stated in a press interview that there were no North Vietnamese
troops in areas controlled by his forces although some North
Vietnamese "military experts and instructors" were in the Plaine des
Jarres. Such statements are contrary to the facts.

2. The five American prisoners released by the Pathet Lao on
17 August have reported the presence of North Vietnamese forces
in Laos. Grant Wolfkill, NBC cameraman-correspondent, has
described his own personal experiences with North Vietnamese troops
and has estimated that 10,000 North Vietnamese were in Laos--a guess,
incidentally, quite close to our own estimates of between 9,000 and
10,000.



[REDACTED] Road Watch teams have also reported the movement of trucks containing North Vietnamese troops toward the DRV border. However, these sources of intelligence are not going to provide a final and definitive answer to the question of whether or not all North Vietnamese have left Laos and certainly will not support a legal case before the ICC. The attitude taken by Souvanna Phouma and Souphanouvong [REDACTED] might have been prompted by the reported "deal" in which Souvanna Phouma promised the Vietnamese and Chinese Communists that he would keep their presence a secret. In turn, they promised to withdraw from Laos. Therefore this suggests that it will be difficult to determine if the Vietnamese Communists withdraw and certainly difficult to "prove".

At the Special Group (CI) meeting of 16 August, in dealing with the training committee's report on the country team seminar, it was agreed that the name "Problems of Development in Internal Defense" should be retained although there was some objection to this and it was agreed that the reference to "country team seminar" could be used as a short form reference. At the Special Group meeting of 16 August, [redacted] explained a plan to brief NATO representatives and heads of NATO states on certain aspects of KH.
