[redacted] has been in touch with various Agency officials since 1959 to offer his services to us in a European assignment. In retrospect, the Agency's responses have been perhaps more kind than candid. These approaches have been acknowledged with a polite thank you indicating no immediate interest but we haven't said to [redacted] in plain language that we had neither present nor future interest in his offer to be of service. Conceivably, he could be an "asset in place" if he were located [redacted] but the possibilities seem to be too remote to justify our employing him and placing him there.
