I am pleased to inform you that recent meetings between our Technical and Security representatives have resulted in the formulation of specific requirements relevant to the problem of minimizing injuries from glass fragmentation during terrorist attacks on our overseas posts.

As a result of this further identification of the problem we can now proceed into the testing phase of the program. We shall continue to need assistance from your personnel in evaluating systems and products for eventual use. I have been informed that the present working group composed of State and CIA representatives will continue to work closely on this project.

In view of the importance of this program to the community, we shall give it the highest priority consistent with our current commitments.

In my letter of 19 July I suggested that, after further study by our respective security and technical staffs, the Agency could consider undertaking research aimed at protection of our overseas people against glass fragmentation injuries.
