Dear Ruf:

I am enclosing a memorandum which I propose to submit to Dick Helms on the subject of the PFIAB recommendations concerning coordination of intelligence production. Since receipt of your memorandum of 7 July, I have discussed the PFIAB panel report with a number of representatives of CIA and, at considerable length, with Tom Hughes. I have also had the benefit of a conversation with General Carroll.

I think that my memorandum represents a general consensus of views. Prior to the actual meeting of the PFIAB, now scheduled for 28 and 29 July, I propose to summarize the discussion and recommendations of this memorandum for Dick Helms' signature by way of a formal response to the Board's report. He will recommend to the Board that General Carroll and Mr. Hughes participate in any discussion of the subject which is scheduled at the Board's meeting. In the meantime, if you have any serious disagreement with my memorandum, please let me know.
