Dear General Carroll:

Thank you for your letter of 16 March concerning the draft estimates program. By now you will have received the 22 March draft of the Quarterly Estimates Schedule which the USIB is to discuss on 31 March. I consider the draft schedule to be a feasible one, and I trust that it can be executed without major slippage.

I suggest that Section C of that draft (Estimates to be Produced Beyond the Third Quarter 1965) be fleshed out as follows, the timing of certain items slightly changed from your letter's proposals:

In preparing to provide necessary intelligence support to the Joint Staff during 1965, we have recently reviewed the schedules, some firm and some tentative, for the production of national estimates. 

Planned for the Last Two Quarters:

- o Intelligence Assumptions for Planning, Section 1 (Strategic Attack Forces), November 1965
- o NIE 11-14-65, "Capabilities of the Soviet General Purpose Forces, 1965-1971," November 1965. (Revision of corresponding section of Intelligence Assumptions for Planning is likely to be ready for USIB approval by early January 1966)

While the foregoing is reasonably well aligned with Joint Staff planning schedules, I would like to point out that there is very little leeway in some instances. Major slippage, particularly in the first two quarters, will have a highly disruptive effect and it is therefore hoped that every effort will be exerted to avoid the delays that plagued us during 1964. I have directed that all concerned components of DIA will insure that necessary deadlines are met.
