MEMORANDUM FOR: Deputy Director for Intelligence

1. General Carter has read the attached letter from General Carroll and he asks that a reply be prepared for his signature as soon as possible. General Carter also asks for the background on specific points raised in the Carroll letter. For example, he would like to know the answers to the following:

a. What is the nature of the personnel rotation referred to by Carroll? Is this rotation within NPIC or from NPIC to other components within the Agency?

b. General Carter is concerned about the implication of the 5th paragraph in the Carroll letter. Does this mean that there is a special enclave of PI experts at NPIC who only serve CIA needs?

2. In short, General Carter, in addition to requesting a response for his signature, asks what NPIC personnel programs are, and for a rationale of these programs.
