MEMORANDUM FOR CHAIRMAN, GUIDED MISSILE AND ASTRONAUTICS
INTELLIGENCE COMMITTEE

SUBJECT : USIB Publication Covers

1. The Chairman, United States Intelligence Board, has directed that the covers for any USIB publications should have a distinctive format so that they can be easily identified.
2. Designs along the general lines of the attached sample covers have been selected. You will note the following basic pattern which will be adjusted to fit the particular publication:
 - a. The distinctive symbol in the upper left to indicate USIB auspices.
 - b. The sponsoring committee or agency and the subject appropriately placed in the center.
 - c. The classification and dissemination notice in the upper right, followed by a colored stripe if needed to designate whatever compartmented security channels are required.
 - d. The identification in the lower left of those channels through which the document must be handled.
 - e. The classification, control number, document number, date and copy number in the lower right.
3. Covers of this design should be used on those USIB and USIB committee publications which have the approval of the Board or which are prepared for publication under the direction or authorization of the Board.

4. The USIB Secretariat will act as coordinator for the use of these USIB publication covers. Mr. Robert Koke (extension 7434) will coordinate the design of the publication covers and is available to advise on them as requested.

5. Accordingly it is requested that each USIB Committee Chairman review any publications prepared under the auspices of his committee, and advise the Secretariat regarding those for which the approved cover design should be used.
