1. In the context of a conversation with General Carroll about research generally, I raised the problem of the

attitude, however, General Carroll has asked General Quinn to raise the question of coordination of R&D and technical support requirements with you.

2. General Carroll thought that the subject should be extended to include the problem of Air Force activities in the research field which [Redacted] brought to your attention. He agrees that the whole question of technical support requirements should be rationalized and indicated that DIA is willing to rely on CIA as the source of support in this field. General Carroll indicated that the technical contracts may very easily have been initiated by some totally uncoordinated element of the Air Force, such as SAC. In any event, he would be glad to go into it.
