1. This memorandum submits a recommendation for your approval; this recommendation is contained in paragraph 3.

The Office of Security considers it advisable and timely to remind the Deputy Directors and Heads of Independent Offices that it is their responsibility to ensure a continuing need-to-know for personnel under their cognizance to retain special access to our sensitive intelligence protected by [redacted] and SI Control Systems. It is the opinion of the Office of Security that the most significant reiteration of this responsibility can be effected by memorandum to the Deputy Directors and Heads of Independent Offices signed by you. The CIA SIGINT Officer concurs in these considerations.

The attached memorandum to Deputy Directors and Heads of Independent Offices is offered for your consideration and signature to request that they review now, and no less than semi-annually thereafter, their records of staff employees, consultants and personnel service contractors to ensure periodic certification of a continued need-to-know for holders of special clearances in the [redacted] and SI Control Systems.
