SUBJECT : Edda Mussolini Ciano

1. In accordance with our telephone conversation this morning, the pertinent portions of the letter to Mr. Dulles from Assistant Attorney General Dallas S. Townsend concerning Edda Mussolini Ciano and her three children are set forth as follows:

25X1 "It appears from further information contained  
25X1 in our files that prior to entering into the contract  
25X1 with Edda Mussolini Ciano, a representative of the  
Chicago Daily News consulted [REDACTED]  
[REDACTED] and obtained ap-  
proval of the contract as well as of the publication  
of the diaries. It also appears that on January 13,  
1945 you acknowledged in writing [REDACTED]  
that Edda Mussolini Ciano had arranged for you to  
take photographic copies of the diaries; that she had  
expressed a desire to make the information available  
in the hope that it would be useful to the Allied cause  
in the prosecution of the war and shed a new light on  
past history; that copies of the diaries would be for-  
warded to Washington for the information of the Govern-  
ment, together with a copy of a letter from Edda Mussolini  
Ciano dated January 8, 1945, stating that the material  
was to be used for official purposes only and that the  
turning over of the copies was not to affect any rights  
which she may have had with regard to the eventual  
commercial publication of the diaries.

"As you know, Section 32(a)(2)(C) of the Trading  
with the Enemy Act, as amended (50 U.S.C. App. § 32),  
prohibits, with certain exceptions not material here,  
the return of vested property to individuals who were  
voluntarily resident within Germany at any time since  
December 7, 1941. It would be appreciated, therefore,  
if you would advise this Office of any information which  
you may have from your own personal knowledge or from  
the files of your Agency with respect to the circum-  
stances surrounding the Ciano family's stay in Germany  
from August 27, 1943 until November 4, 1943, and the  
reasons therefor."

2. The individuals concerned are Edda Mussolini Ciano, wife of Count Galeazzo Ciano; and their three children, Fabrizio, Raimondo and Marzio Ciano. The diaries referred to are the Ciano Diaries published pursuant to contracts entered into by Edda Mussolini Ciano [redacted] in 1945 with the Chicago Daily News and Doubleday, Doran & Company.

3. Please forward to us whatever information the Agency files may contain. You should include, in addition to the information requested in the last sentence, quoted above, any information referred to in the first of the quoted paragraphs. I suggest that your response be in narrative form, with as many direct quotations and named sources as possible.

4. Since the Director intends to sign the reply to the Assistant Attorney General there is some urgency to this.
