Dear Mr. Rogers:

I wish to acknowledge your letter of 19 April 1954. Please be assured that this Agency is fully cognizant of the problem presented to your Department, and specifically to the Immigration and Naturalization Service, by enrolled private immigration bills.

Over the past months we have worked out a system of twenty-four hour priorities, special messenger service, and telephone replies to the Immigration and Naturalization Service in connection with the enrolled bills. Both the Immigration officials and those of the Bureau of the Budget have expressed themselves as satisfied with the service received on these requests. Occasionally, as I am sure you will understand, the voluminous number of bills to be searched in connection with a specific name makes it a physical impossibility to reply within the desired time period. In these instances, the Immigration and Naturalization Service is telephonically notified.

Please accept my assurances that this Agency will continue to cooperate in every way possible in this regard.




