Finally, we would want to comment on the importance of his keeping himself in fit physical condition and of developing a sound character and community reputation.

It is heartening to know that young people like [redacted] are ambitious to serve their country and we hope that he will persist in his patriotic goals regardless of the particular career he might decide to follow.
