Dear Mr. Holtfield:

I have your letter of 8 May referring to the particular interest of the Joint Committee in Soviet weapons tests and your specific request for National Intelligence Estimate [redacted]. As you are probably aware now, a copy of this Estimate and a Restricted Data Annex were hand delivered to the Joint Committee staff on 8 May 1961. At the time of delivery of the Estimate it was suggested that if the Joint Committee or the staff wished any further briefing we would be pleased to make the necessary arrangements.

In your letter you also request the Agency to furnish such documents as this relating to atomic energy to the Joint Committee on a continuing basis. Please be assured that I have every desire to assist the Joint Committee in any way possible. In connection with the timing of actual delivery of Estimates, I should like to point out that the date normally appearing on an Estimate reflects the date of approval of the Estimate by the United States Intelligence Board and some days may elapse, depending on existing priorities, before the Estimate is printed in its finished form. I am informed, however, that my representatives have discussed with the staff of the Joint Committee a system of alerting the Joint Committee staff when an Estimate has been approved with the view that the Joint Committee will have advance notice of any particular Estimate prior to final printing and delivery to the Joint Committee.

5. This letter from Holifield is also another manifestation of the suspicion on the part of the staff members of the Joint Committee that the Agency is not providing full information. This situation is discussed in detail with appropriate recommendations in my memorandum to the DCI dated 10 April 1961. I believe there is danger of a serious deterioration of relationships unless the Agency can resolve some of the doubts that have arisen in the minds of certain of the staff members and possibly the Committee members.
