Dear Mr. Bell:

I have reviewed the Enrolled Bill, H. R. 8599, "To amend various sections of the Atomic Energy Act of 1954, as amended, and the EURATOM Cooperation Act of 1958, and for other purposes." Only Section 6 of this bill is of concern to this Agency. This Section would permit the Atomic Energy Commission to grant access to Restricted Data to our employees on the basis of a Central Intelligence Agency security clearance and investigative report. This would eliminate duplication and time-consuming investigations which are required by present law.

By letter of 15 March 1961 the Agency commented favorably on the Atomic Energy's draft bill which contained identical language. I believe the provisions of Section 6 of the bill would materially assist our activities and, therefore, I favor its enactment. However, my views are restricted to Section 6 since the remainder of the bill deals with matters which are not within the responsibility of this Agency.
