MEMORANDUM FOR: General Cabell

SUBJECT: Intelligence Directives

1. This memorandum requests approval of a recommendation contained in paragraph 5.

2. During the considerations of the Joint Study Group (JSG) on Foreign Intelligence Activities of the United States Government, the Group members had available copies of all NSCID's and DCID's. Mr. Robert Macy was issued by CIA (OCR) a complete set of the NSCID's and DCID's, except DCID 6/3 (Communications Intelligence Regulations). Mr. James Lay was issued the DCID's only. The other three members used the documents previously issued to their respective agency or department. The Bureau of the Budget (BOB) did not have these documents prior to the establishment of the ad hoc Study Group.

3. Mr. Lay has turned back his set to OCR and will use the files of the Coordination Staff. Mr. Macy finds that these documents are very useful to the BOB. Mr. Ecker, Chief, State-USIA-CIA Area under Mr. Macy, who was also a staff member of JSG, requests authority to retain the documents (Tab A).

4. The set now in possession of Mr. Macy is out-of-date. I suggest that the set be called back by this Staff and returned to OCR (the office of record) with a request that a complete set be reissued to Mr. Macy less NSCID No. 6, DCID's 6/1, 6/2 and 6/3 all pertaining to aspects of Communications Intelligence and Electronics Intelligence.

5. I recommend your approval of this request from Mr. Ecker of the Bureau of the Budget.
