The Federal Bureau of Investigation has submitted information to this Division concerning recent activities of the following individuals and has requested our opinion as to whether possible violations of the Neutrality laws are indicated and whether further investigation is desired:

Information furnished to us by the Federal Bureau of Investigation reflects that these individuals allegedly offered a proposition to a former Cuban officer [Redacted] for the purpose of training anti-Castro Cubans for an invasion in Cuba. [Redacted] reportedly claims to have four or five large farms in the vicinity of Newark, New Jersey, at his disposal for the training of recruits for such an invasion. [Redacted] reportedly was offered the position of Commander at one of the farms to train approximately 170 to 200 Cubans, with pay to be approximately \$200 a week. Cassidy reportedly also claims to have some


