

STAT About six months have elapsed since you were kind enough to attach Mr. to my office as your liaison with the Secretary of Defense. It might be useful to you to receive a little report from me on how well he has performed his duties, from our viewpoint.

STAT Mr. assistance has been constant and invaluable. I believe that a large share of the credit for the harmonious and constructive relationship which exists between CIA and Defense is a direct result of his mature judgment, energy, and dedication to the ideal of serving the United States. These qualities have permitted him to make substantial contributions to my direct staff support of Secretary McNamara and Deputy Secretary Gilpatric, in particular, as well as in the staffing of other mutual CIA-Defense problems. 
