MEMORANDUM FOR THE DIRECTOR OF CENTRAL INTELLIGENCE

SUBJECT: Security Arrangements for
Dr. Henry A. Kissinger, Cambridge, Massachusetts

Dr. Henry A. Kissinger, of the Harvard University Institute of International Affairs, Cambridge, Massachusetts, is serving as a part-time consultant to the President and the National Security Council.

Although Dr. Kissinger's personal secretary at Cambridge has been granted Top Secret clearance by the NSC, the office quarters themselves cannot be approved for unattended storage of sensitive materials without the installation of alarm system and related equipment which would probably prove to be more elaborate than effective for the purpose. A present interim arrangement involves the use of the CENIS library at MIT as a classified repository, which imposes on several CENIS people the responsibility of having access to and custody of our sensitive materials.

I would therefore like to ask your help in accommodating the President's and Dr. Kissinger's needs in facilitating the handling and safeguarding of the small amount of classified materials which will be involved at Cambridge. It would be very much appreciated if you would provide us with the support of your agency in the form of (1) Top Secret courier service between the NSC and a secure delivery point in the Cambridge area, (2) the use of a Top Secret repository in the Cambridge area for the secure storage of classified materials to which access will be restricted to Dr. Kissinger and his secretary as far as practicable, and (3) Top Secret courier service between the repository and Dr. Kissinger's office to permit storage of such materials overnight, weekends, holidays, etc.

Mr. Russell Ash of my staff will be available to meet with your representatives should any further details be required.
