MEMORANDUM FOR THE DIRECTOR OF CENTRAL INTELLIGENCE

SUBJECT: Provision for Early Warning of "Cold War" Crisis Situations (Recommendation Number 4, of the July 2, 1961, Report to the President by the President's Foreign Intelligence Advisory Board)

For your information there is enclosed herewith an excerpt from the report made to the President by his Foreign Intelligence Advisory Board on July 2, 1961, entitled "Early Warning of 'Cold War' Crisis Situations", pertaining to the recommendation referred to above.

The President has noted the recommendation that the United States Intelligence Board (USIB) establish the means for meeting requirements of early warning of cold war crisis situations developing in any part of the world, and that such early warning be handled separately from indications of hot war dangers involving the Communist Bloc which are presently dealt with by the National Indications Center and the Watch Committee.

Before taking final action on this recommendation the President has requested that the USIB submit its views as to the most effective means of achieving implementation of the recommendation.

Accordingly, it is requested that you place this matter before the United States Intelligence Board for consideration and that this office be furnished a report thereon by August 21, 1961. A copy of your report should also be furnished directly to the President's Foreign Intelligence Advisory Board for its information and further consideration as deemed appropriate.

EARLY WARNING OF "COLD WAR" CRISIS SITUATIONS

The Director of Central Intelligence, Mr. Dulles, suggested that the United States Intelligence Board make arrangements for early warning of developing "cold war" crisis situations in any area of the world.

We recommend that the United States Intelligence Board be instructed to create the means for such early "cold war" warning. We recommend, further, that such early warning be handled separately from indications of hot war dangers now dealt with by the National Indications Center and the Watch Committee.


