**SUBJECT: Purported Khrushchev Admission of Espionage
(11 May 1959)**

1. The internal evidence in this purported quote from Khrushchev clearly indicates that this kind of statement would never be made publicly by Khrushchev, or indeed by any modern-day Soviet leader. First, the phraseology throughout this quote is of the kind that the Soviet leadership in its public pronouncements rarely, if ever, uses. (For example: "leave them to flounder helplessly," "our appropriation of power," "Soviet domination recognizes neither liberty nor justice," "annihilation of the individual will," "great cruelty can signify supreme merit," and "reduce humanity to a state of docile subjection.") Secondly, substantive admissions of the kind made in this statement would represent an appalling and irretrievable breach in the monolithic communist propaganda line.

2. Concerning external evidence as to the authenticity of this "quotation," we have examined our file of Khrushchev speeches publicly released by the USSR and find that while Khrushchev made a major speech in Kiev entitled "For New Successes in the Development of Soviet Agriculture" on 11 May 1959, it contains no such statement.


3. We have examined the FBIS Daily Report and the New York Times index for an 11 May Reuters dispatch which might have contained such a reference, but we find in these two sources no record of such a dispatch. Speeches for several days on either side of 11 May were also checked with negative results.

4. From the wording of Mr. Aldrich's 18 May hectograph memorandum, it is unclear as to whether Claude Meyer in Lausanne, Switzerland, is a Reuters correspondent or whether some Reuters correspondent may have been quoting from a book published by Claude Meyer in Lausanne with the title indicated. In our judgment it is tantamount to impossible that any Soviet propagandist would entitle any speech "The Explanation and Diffusion of Fundamental Errors of Marxist Doctrine."
