I appreciate the opportunity to review your coming presentation to the University of Chicago Graduate School of Business Administration.

We have only one substantive suggestion, and that is on page 6 of the draft. Where you now say in paragraph 1, "The rate of economic growth is also important in that it is a measure of military potential," it would probably be clearer to say, "The rate of economic growth is also important in that it is a measure of the growth of military potential." This would be consistent with the thought which follows in the next sentence, that is, the greater the total output of goods and services, the greater can be the military effort.

I am pleased to see your serious treatment of the Soviet's economic challenge.
