Dear Gerry:

This letter will supplement the previous one of 11 January 1960 which listed the congressional hearings before which I was at that time scheduled to appear. All of the appearances listed in that letter were made except for Senate Armed Services set for 2 February which was cancelled by Chairman Russell in view of my scheduled appearance before Senate Preparedness Investigating Subcommittee which occurred on 29 January. The Chairman thought that since all members of Senate Armed Services were ex officio members of the Senate Preparedness Investigating Subcommittee this would afford them the opportunity for this particular intelligence briefing.

In addition to the hearings mentioned in my previous letter, I was requested to appear and did so before the Joint Committee on Atomic Energy on 24 January at two o'clock and the CIA Subcommittee of House Armed Services Committee on 5 February at ten o'clock.

The only hearing now scheduled is the Subcommittee on National Policy Machinery of the Senate Committee on Government Operations for Wednesday, 17 February, at ten o'clock. The subject of the briefing of the National Policy Machinery Subcommittee will be the long-range policy and objectives of the Soviet Union. In addition, it is quite likely that I will be requested to appear again before the Senate Aeronautical and Space Sciences Committee and Senate
