

SUBJECT : Public Statement Regarding United States
Intelligence Board

1. On 14 October 1958, shortly after the United States Intelligence Board (USIB) was established, the Board agreed that the membership of USIB should be treated as unclassified. As you are aware, in the past few weeks there have been public references to the existence of the Board. Also, inquiries have been made by the press regarding the composition of the USIB, including at a recent Presidential news conference.

2. In the light of these developments the Board, on 4 February, agreed that the attached statement regarding the USIB and its present membership would be suitable for public release. The Board members further agreed that I should forward the statement to you, indicating that they would not object to its release by the White House.

The United States Intelligence Board (USIB) was established on 15 September 1958, pursuant to action by the National Security Council (NSC). It is the successor organization to the Intelligence Advisory Committee (IAC), also established by the National Security Council following the enactment in 1947 of the National Security Act which included among its provisions the statutory basis for the Central Intelligence Agency.

The membership of USIB includes all of the members of the IAC and certain others having intelligence functions. Also the USIB carries on the duties of the IAC with certain expanded responsibilities, and with the same regular meetings, weekly, or oftener as circumstances require.

Both the name and membership of the Board are unclassified.

The present composition of the Board is shown on the attached list.
