Dear Mr. Chairman:

Your letter dated 19 February 1960 outlining a special collection project has been carefully considered and Defense participation has been approved.

The Department of the Air Force will provide, operate, maintain, and support one KC-135 aircraft. Within the Department of Defense, the Advanced Research Projects Agency will provide \$4 million toward the modification and instrumentation of the aircraft. It is my understanding that the Central Intelligence Agency will provide \$2 million toward the project.

It is our intention that this project be implemented on an urgent basis.
