Enclosure: Draft "Terms of Reference"


1. It will be necessary in March of 1960 to prepare a new NATO Standing Group Intelligence Estimate (SG-161/13) covering the period 1960 through 1964 and where feasible through 1966. This estimate will provide:

- a. The Standing Group with an intelligence estimate on which to base NATO planning;
- b. Major NATO commanders with intelligence guidance on which to base their defense plans and force requirements;
- c. NATO nations with military intelligence.

2. The enclosed Terms of Reference are proposed for preparation of the U. S. position paper. While providing for much of the same type of material as SG 161/12, these Terms of Reference present some changes in format and are essentially the Terms of Reference proposed by the NATO Standing Group.

3. Both the British and the French have recommended a new approach to the "campaigns" part of the estimate (Part III) and the draft Terms of Reference for the U. S. position paper generally coincides with their recommendations.

4. Your early comments on the enclosed draft Terms of Reference would be appreciated.

(4) Air Support. General statement of the role of the tactical air force in support of land operations, with cross-reference to the table giving disposition of aircraft in Part II;

(5) Airborne Forces. Total availability and capability;

(6) Naval Support. General statement of the type of support likely to be available, with cross-reference to the table giving disposition of Soviet surface forces in Part III;

(7) Amphibious Forces. General statement with cross-reference to total capability in Part II;

(8) Logistic Considerations. General statement on communications capacity;

(9) Summary of General Considerations. Conclusions based on factors above leading to discussion of particular campaigns.

B. Campaigns. For each of the four main theaters, i.e.:

- Western Continental Europe
- Scandinavian Peninsula
- Southern Europe
- Eastern Turkey, Iraq and Iran

(1) Soviet Aim;

(2) Magnitude and Composition of All Forces Involved

(3) Logistic Considerations. To include communications capacity;

(4) Direction and Method;

(5) Supporting Activities;

(6) Indication of Subsequent Soviet Operations.

2. Whenever feasible, the estimates will be projected through 1966.


