MEMORANDUM FOR THE DIRECTOR

1. This memorandum recommends action in Paragraph 2.


2. Recommend that you concur in Recommendation 5 b that the State Department in future refer directly to the Agency for clearance any classified material bearing on COI/OSS which the Department proposes to publish.

Recommend that you non-concur with the recommendation in Paragraph 5 a from Chief, FI, and that you authorize the publication of these documents under the conditions stated by the State Department.

3. In each of the instances cited by the State Department, the British and the Spanish governments have agreed to the publication and in the case of the Spanish Zone of Morocco, as State Department mentions, Col. Eddy's intelligence activities are referred to in the Official U.S. Army History of the Mediterranean Theater of Operations. We seem to be inconsistent in protecting sources and methods.

4. It would seem that the State Department's regulations covering their issuance of historical papers under the State Department imprint on these matters which are of primary concern to them would result in the DCI granting the permission they request. In the case of North Africa, it has been stated in the

Press recently that Mr. Murphy is writing a book on his experiences in that area. There of course have been publications by General Mark Clark and others on phases of the Murphy-Clark-Lemnitzer submarine trip. Julius C. Holmes did a detailed report some years ago for the SATURDAY EVENING POST.

5. While the Director is responsible for protecting intelligence sources and methods, it would seem in these instances that there will be no violation of security and no exposition of anything new or novel in intelligence methods and sources that would cause the State Department not to publish these documents.
