Dear Mr. Hoover:

This is with reference to the article in the September issue of "True" magazine concerning the CIA, in which certain remarks are made with regard to the FBI and yourself. Mr. Kuhrtz discussed this matter with me on 12 August, and Mr. Papich on 25 August.

Let me say first that I consider any matter that could in any way affect the fine relationship that has been established between the FBI and the CIA would be most regrettable. The comments made in this article in this regard are totally false and in no way represent my views or those of any responsible member of this Agency.

As Mr. Kirkpatrick explained to Mr. Papich on 24 August, it has been the consistent policy of the Agency neither to confirm nor deny or to approve or disapprove articles appearing in the press. We will, upon request, look at an article to determine whether there are items revealing intelligence sources and methods, the protection of which I am charged with by law. Mr. Kirkpatrick advised Mr. Papich of the facts in this particular case. I would particularly point out that the initial manuscript contained only two paragraphs on the FBI, while the later galley proofs had an expanded version. On both occasions we suggested corrections.


