

Dear Mr. Floete:

I have your letter of September 29, 1959, concerning discussions between representatives of our agencies with regard to the operation, maintenance, protection, repair and related utilities service for our new headquarters building at Langley, Virginia.

It is our desire that your Administration obtain annual appropriations and perform these services upon completion of the building. In this connection we assume that your operation of the building will also include maintenance of grounds, roads and parking areas. The utilities which should be provided under contracts executed by the General Services Administration include electricity, water and sewage disposal. Telephone service is not included in the above as the Central Intelligence Agency will assume responsibility for budgeting and contracting for this utility.

Enclosed is a copy of your September 29, 1959, letter which I have signed in accordance with your request.
