Dear Mr. Dulles:

Plans are now being undertaken for the fall campaign for Red Feather agencies of the Community Chests in the National Capital Area. A first step is the development by the Quota Committee of equitable unit goals for all departments and agencies.

Therefore, will you cooperate by furnishing the following information, as soon as possible, to Mr. William G. Gilks, Manager of the Government Unit, Room G 133, GSA Building:

1. The number of your employees as shown by your latest payroll period. This information should include field employees stationed in the National Capital Area. Field, seasonal employees and employees having their offices away from the National Capital Area should be EXCLUDED.
2. Total of the annual base salaries of employees covered by "1".
3. Should you anticipate any substantial change in the number of your employees or the amount of your payroll by October, please furnish the best estimate for both "1" and "2" projected to the first payroll in October.

Mr. Gilks and his staff will be available to assist with any details of the campaign, and you can be assured of his wholehearted cooperation.
