

Dear Mr. Dulles:

It has become increasingly apparent within the last few days that the 1961 National Health Agencies campaign can not be successfully concluded by April 15. A number of agencies, including my own department, are still far from achieving a reasonably satisfactory participation record.

I believe that we can put this campaign over the top if we have just a few additional weeks in which to concentrate on hard campaigning. Accordingly, I am asking all agencies, and especially those which have not reached at least 75% participation, to extend their National Health Agencies campaigns until they achieve a substantial response. If we redouble our efforts, there is no reason why this cannot be accomplished in each and every agency by the end of April or early in May.

The extension period will cover another pay day in most agencies. It will, therefore, provide an excellent opportunity to make sure that everyone has made a contribution to the campaign. I am sure that you will take whatever steps you consider most appropriate to see that the campaign volunteers in your agency are organized and prepared to take full advantage of the extension period.
