SUBJECT: Letter from Chairman John F. Doherty, ICIS, dated 20 October 1961 (file #ICIS - P1/240)

1. This memorandum transmits a letter for the signature of the Acting Director of Central Intelligence.

2. Chairman Doherty's letter of 20 October requested CIA (1) to concur in a recommendation by ICIS that a Working Group on Travel Documents be formed to advise interested departments and agencies in combatting and preventing the fraudulent use or forgery of U.S. travel documents, and (2) to designate a representative to participate in the program.

3. The attached proposed reply approves the ICIS recommendation and designates [redacted] of this Staff as CIA member of the Working Group. The reply has been coordinated with the Office of Security, and your signature is recommended.


Dear Mr. Dulles:

The Interdepartmental Committee on Internal Security has under consideration the enclosed draft report dated April 28, 1961, on the implementation of Executive Order 10501, "Safeguarding Official Information in the Interests of the Defense of the United States." It is requested that the United States Intelligence Board furnish any comments it may have concerning the report, especially any specific changes deemed necessary in Annexes B, C, D, E, and G.

We are also directing a similar request to the following departments and agencies: Defense, Justice, State, Treasury, Commerce, Post Office, Atomic Energy Commission, Central Intelligence Agency, Federal Aviation Agency, National Aeronautics and Space Administration, and the General Services Administration.

It is understood that proposals have been received by the White House for revision of certain aspects of Executive Order 10501. We will therefore appreciate the Board's comments as soon as possible in order that the heads of the departments and agencies concerned may have our final report on this matter for their consideration in connection with any specific proposals for amendment of the Order.
