

Dear Allen:

Reference is made to your letter of July 23 with which you transmitted the "Report of the Survey of Intelligence Needs and Assets of the U.S. Information Agency." I agree wholeheartedly with the conclusions reached in the Report.

I have approved those recommendations which relate to my area of responsibility, and have commenced the staff work necessary for their implementation.

I agree that implementation of the Report will require continued consultation and cooperation between the interested agencies, especially during the critical formative stages of our own Intelligence Unit. I am designating Mr. Henry Loomis as a central point within USIA for such consultation with Mr. Bissell who, with his staff, has won the confidence and respect of every element of USIA with which they have come in contact.

The survey has already helped solve some of our most pressing problems. Several new procedures have been established, both within USIA and between USIA and other agencies, as a direct result of the survey. I have every hope that adoption of all the recommendations will result in a major improvement in intelligence support for USIA, and in utilization of its intelligence assets.
