After the U.S.I.B. discussion and the decision over a year ago to proceed, under certain conditions, with the purchase, negotiations were subsequently initiated. An offer was made and after adjustments a general basis of agreement was reached. While a number of details remain to be ironed out the situation has reached a point where I do not feel that, in good faith, we can now withdraw if the other party insists on proceeding. In fact, to do so might well result in counter claims. Nevertheless, we appreciate your suggestion of the possibility of an alternate plan. If this proves to be of interest to [redacted], we are prepared to explore this suggestion with him in consultation with you.
