1. The Honor Awards Board considered the recommendation for award of the National Security Medal to [redacted] on 9 May 1955. The Board asked Mr. [redacted] to sit with it as a consultant during a portion of its discussion.

2. The Board agreed unanimously that the service rendered, while meritorious, does not warrant the award of the National Security Medal. Its reasons for the decision are as follows:

a. The Executive Order creating the National Security Medal and the regulations accompanying the Executive Order were intended to create an intelligence decoration of a stature equal to or above the Distinguished Service Medals of the Armed Services. In establishing working criteria the Board considers that the standards must necessarily be those of extraordinary merit rather than those of superior performance. By comparing the description of [redacted] services as set forth in the letter from Lieutenant General Ralph J. Canine, Director of the National Security Agency to the Director of Central Intelligence against the type of service for which the National Security Medal has been previously awarded, the Honor Awards Board concludes that [redacted] services do not meet the standard of extraordinary merit.

b. The position occupied by [redacted] and the length of time he has been in occupancy would indicate that at least seven (and perhaps more) outgoing incumbents might be recommended for similar honors in less than three years time. The National Security Medal might well become an "automatic" award for a job well done.


