

SUBJECT: CIA Representation on NESC Staff

1. When Mr. Dulles asked you to release Mr. [redacted] from your Staff, he indicated that Mr. [redacted] would be replaced if the Staff received further responsibilities in which CIA assistance was required. General Twining's memorandum of 17 May indicates that the President has approved a study to be completed in April of 1961.

SUBJECT: CIA Representation on the NESC Staff

1. When I asked you to release Mr. [redacted] from your Staff, I indicated that I would replace Mr. [redacted] if the Staff received further responsibilities in which CIA assistance was required. I learn from General Twining's memorandum of 17 May that the President has approved a study to be completed in April of 1961.

2. Under the terms of NSC 5816, which states that the Staff should be "composed of individuals assigned by the member agencies, as required by the Director," CIA has supplied a full-time Staff member, although none of the other civilian agencies has done so. I continue to believe that the Staff should be supplied with the best intelligence which the US Government can provide, and that I should continue to have a competent professional intelligence officer associated with your staff.

3. I would appreciate your views on the possibility of modifying somewhat the role of the CIA officer whom I would like to assign to this responsibility. It appears to me that much of the work of the Staff is confined to military operational analysis best performed by professional military personnel. The intelligence ingredient in this analysis is important, and where it is involved, I am certain it is most helpful to have a professional intelligence officer at hand. Accordingly, I should like to have the successor to Mr. [redacted] serve you as the Intelligence Advisor to the Staff, rather than as a full-time member. In this capacity, he would be available to you at all times when intelligence problems would be involved. I should like, however, to assign him duties in CIA which he could perform when his services were not required by you. Naturally, your needs in connection with intelligence would take precedence over any duties assigned to him here.



I consider him a highly competent and energetic officer, and I feel that he would be a valuable complement to your Staff.




