Dear Mr. Harney:

We, of the Central Intelligence Agency, sincerely regret that your tour of duty as Acting Chief Coordinator of the Treasury Department's enforcement agencies has ended. We realize that to be effective this Agency must have the cooperation and support of all branches and officials of the Government. Yours has been an outstanding example of understanding cooperation. Colonel Edwards and [redacted] have kept me advised of their requests made upon you from time to time, and I have been somewhat apprehensive lest they were imposing upon you too much. 


