

I have checked with [redacted] in OCD who has informed me that a copy of the film "Silvery Dust" is available in his film files. [redacted] stated that originally the fact that this organization possessed a copy of this film was considered highly classified. However, it would seem that since we have once loaned it to the UN, it may be that this fact is no longer so sensitive.

I see no reason for taking further action at this time. I believe we should now merely wait until we receive an official request from General Hopwood for loan of the film. If you agree, I will flag this with ER to have any letter from General Hopwood brought to my attention.

Dear General Heywood:

My apologies for this long delayed reply to your letter of December 15th. It arrived at the time of the adjournment of the UN General Assembly and started chasing me around the country, and only just caught up.

It is true that I was loaned a print of the "Silvery East" film for use in the UN in connection with one of the items assigned to me. However, we managed to defeat the Soviet position without having to use the film, and therefore returned it.

I think that if you were to get in touch with Mr. Allen Dulles, Director of the Central Intelligence Agency in Washington, he would be able to advise you if a print was still available.

You should know that the sound track is in Russian and that there is no English-language dubbing or sub-titling. We did an English-language tape-recorded commentary to be played in synchronization with the showing of the film in order to explain the action. Mr. John Williams of the U.S. Information Agency, 1778 Pennsylvania Avenue, Washington, D.C. would know if this tape recording still exists.
