

Dear General Morse:

Colonel Matthew Baird, presently in an inactive Reserve status, was recalled to active duty 26 December 1950, for a period of three years. During January 1951, at the personal request of General Walter Bedell Smith, then Director of Central Intelligence, he was detailed to the Central Intelligence Agency where he was charged with the responsible position of Director of Training. Upon completion of his active duty tour, 21 June 1953, Colonel Baird remained with CIA in a civilian capacity and has continued an extraordinary performance reflecting the highest credit upon himself and the U. S. Government.

Colonel Baird is a dedicated officer and has rendered outstanding service to this Agency in the intelligence and training fields. He has effectively met with superior qualifications the many technical and organizational demands placed upon him. It should be noted that in the fulfillment of his duties, Colonel Baird's Reserve status has been most useful.
