The purpose of this memorandum is to raise the question of CIA attendance at such briefings, possibly requiring your personal request at a high level of the Air Force.

3. Apart from our general intelligence interest in the substance of these studies, we have a concrete interest in the techniques and methodology employed, since we understand that roughly the same techniques are being used by Rand in its studies of US strategic strikes against the USSR. [redacted] committee on weapons requirements has now urged that the IAC have observers at these latter studies, to get incidental dope applicable to the Soviet weapons mix problem, and to study the techniques.

4. The Project has been presented to the Policy Planning Staff of the Department of State, and we understand is scheduled for presentation to a Navy group late this week. The Rand briefing team will be in town at least until early next week, and my friend
