MEMORANDUM FOR: DIRECTOR OF CENTRAL INTELLIGENCE

SUBJECT: Formalization of Joint Arrangements at CIA/PIC

1. Since 1956, the Central Intelligence Agency, the Army, and the Navy have participated in the joint exploitation of photographic materials from advanced reconnaissance systems at the CIA Photographic Intelligence Center (CIA/PIC). The pooling of processing and supporting resources, which is characteristic of this center, has enabled the agencies participating to exploit most economically photographic materials for national and departmental intelligence to a degree far beyond that which their individual capabilities would have permitted. At the same time the joint reports produced by this center have provided important contributions to national intelligence. The organization and concept of joint operations developed by the CIA, the Army, and the Navy at the CIA/PIC have, in my judgment, been demonstrated as effective, economical, and in the national interest.

2. Recently, however, there has been some criticism voiced by responsible Department of Defense officials concerning the informal working agreement under which Army and Navy participate in CIA/PIC operations. Taking cognizance of the existence of this criticism, this informal arrangement may mitigate against the center as an agency to be given broadened community responsibilities in the exploitation of materials from advanced reconnaissance systems.

3. For this reason, I deem it essential that the arrangements which exist among the participants at the CIA/PIC be formalized. I further believe that such action, at this time, will serve to protect the cordial relationships under which we have worked so successfully in the past. More importantly, it may well provide a suitable framework on which to build an organization for the future.



