I appreciate your letter of 24 June stating that the Critical Collection Problems Committee considers it desirable for the Army to devote further research and development effort to Project LIGHT HOUSE, and am sure it will be helpful.

Although we have been unable thus far to obtain Department of Defense support for this activity because of previous allocation of emergency funds, I am hopeful that it may be possible to reprogram some Army funds for this purpose.
