Dear Admiral Holloway:

Pursuant to the suggestions contained in the February 10, 1955 letter from the Assistant Secretary of the Navy on the subject of [redacted] representatives of CIA and officers of the Bureau of Naval Personnel have held several conferences.

As a result, it is my understanding that the members of [redacted] will be given mobilization assignments to CIA and in the event of mobilization be considered available for recall to active duty and ordered to this Agency. This will necessitate the removal of the names of the members of this Company from the control list of CIA employed personnel presently maintained by the Bureau of Naval Personnel. It is believed that this general procedure will place Naval Reserve members of this Company in the same position as members of other Reserve Companies relative to training duty with pay and other Reserve privileges.

It is further understood that the members of [redacted] when ordered to active duty in CIA, will be credited against any requirement for the Navy to supply CIA with Naval personnel in the event of mobilization.

Attached for your use is a list of names of present members of [redacted]. This list will be modified from time to time as necessary to keep it in a current status.

Your cooperation and assistance in solving this problem and making it possible for Naval Reservists of this Agency to participate fully in Reserve activities is greatly appreciated.

My dear Mr. Director:

The 1955-1956 session of the United States Naval War College is scheduled to convene on 19 August 1955 and will conclude on 13 June 1956. Participation in the two year course in Naval Warfare by non-naval officers and civilian students will be limited to one year of the course; some will take the first year and others the second year. Non-naval students completing either year of the curriculum will receive a diploma "Completed Course in Naval Warfare."

The Department of the Navy again extends a cordial invitation to the Central Intelligence Agency to nominate one official with appropriate background and experience to attend the course in Naval Warfare. The official may attend either the First or Second Year of the course, whichever is preferable to your Agency. Naval officer candidates for the First Year of the course are officers of the grades of Captain and Commander with 15 to 20 years of commissioned service; for the Second Year candidates are officers of the grade of Captain with 20 to 24 years of commissioned service, or officers of the grades of Captain and Commander with 15 to 20 years of commissioned service who have successfully completed other high level military education. It is desired that your nominee for the course be of comparable rank and service experience for whichever year of the course he will attend.

Although non-military students will be permitted in the Second Year of the course in Naval Warfare, attention is invited to the fact that such students will not be permitted to attend a few specific curriculum items for which attendance is restricted to military personnel only.

The usual familiarization training program before the opening of the regular session for personnel of other military services and civilian agencies will be conducted. This program, of one week duration, will consist of lectures, tours of naval installations, and short cruises on Atlantic Fleet vessels including submarines. The Central Intelligence Agency official is invited to participate in the familiarization training and

should report to the President of the Naval War College not later than 12 August 1955 for this purpose. His orders should specify which year of the course in Naval Warfare he is to attend. In addition, if the nominee does not already hold a "Q" clearance, it is requested that he be processed for such clearance prior to arrival at the Naval War College, and that he be provided with a statement indicating a "need to know" basis for receiving restricted data.

It will be appreciated if information can be received at an early date as to the utilization of the proffered billet.
